New Service Rules as well as the Extensions and Resolutions for the Coggon Municipal Light Plant were reviewed. Some additions and corrections were agreed upon. Edits will be made and reviewed again during the July meeting and may be adopted at that time.

Next item discussed was Tyler Rundle's position as part time employee. Since Tyler graduated with honors from Marshalltown Line School and received his CDL he requested a raise in his pay. The board all agreed that Tyler has been an asset to CMLP and was deserving of an increase in pay. Treasurer McClelland made a motion to increase Tyler's wage to \$22.50 effective June 1st, 2023. Trustee Moore seconded the motion, 5 ayes and the motion passed.

The expansion project at Buffalo Creek Campground is moving forward. Materials have been received, waiting on the transformers and then MJ Electric will be able to install the primary service on behalf of CMLP. All labor and materials costs will be passed onto the Linn County Conservation once MJ Electric begins work.

The project to help distribute the load from Casey's more evenly has been completed. However, the underground portion of the primary going up the hill on 3rd street has a melted connection at the riser pole. This would mean that there is likely a fault somewhere underground so repair to this is necessary to allow the circuits to unload evenly. From there the main sub station will be upgraded to allow plans to move forward on the new substation.

Trustee Vosdingh motioned to adjourn at 7:13 pm, Treasurer McClelland seconds, 5 ayes and motion to adjourn carried.
