The Coggon Municipal Light Plant Board of Trustees met in regular session on Monday, June 8, 2020 via ZOOM. The meeting was called to order at 7:21pm by Chair Hart. MJ Electric provided a standard contract agreement which was reviewed by the board. It was agreed to have the attorney assist with the language to provide on the contract for the scope of work to be performed.

The bucket and digger trucks are both due for their annual inspections. Mary will provide the board with the costs from 2019 for each of the inspections to determine if the inspections should be completed due to the lack of use at this time.

The new Water softener installed in 2015 is no longer in use so it was determined that it could be sold.

The board agreed to pay employee Rundle \$20 each time she uses her personal mower to mow the plant yard.

Chair Hart mentioned that he wanted to continue to have a good working relationship with the City. Deb Hinton, of Coggon Public Works explained that the shut off at the plant has been broken for some time that that the plant would be responsible for digging up the shut off valve to have it repaired. The board agreed to get quotes for the repair work. Heather Beeh, Mayor of Coggon, voiced concern for the light plants open position. The position continues to be advertised with the IAMU. The board has interviewed, but struggles to find qualified candidates. Due to this, safety reasons and the cost to hire someone qualified, the board all agrees that the work will be contracted out.

Treasurer McClelland motioned to adjourn at 8:23 pm, Secretary Manternach seconds, 4 ayes and motion to adjourn carried.
