

The Coggon Municipal Light Plant Board of Trustees met in regular session on Monday, January 10, 2022 at the Coggon Light Plant. The meeting was called to order at 6:01pm by Steve Hart. Those in attendance included, Steve Hart, Vaughn McClelland, Michelle Manternach, Bill Vosdingh and Chuck Moore as well as employee Mary Rundle. Jennifer Woods was also in attendance.

Jennifer Woods addressed a bill that she received from CMLP for charges from Price Electric for installing a new underground service line, which was the home owner's decision. Jennifer stated that due to the existing trees in the service line, choosing to put the service underground would save CMLP future maintenance and requested a discount. The board agreed to rebill and charge the home owner \$10 per foot from the pole to the meter which Jennifer agreed to be fair as well.

An election of the 2022 officers of the Light Plant board was next on the agenda.

Bill Vosdingh moved to keep the existing positions as is. Chuck Moore seconds, roll call vote: Chuck Moore agrees; Vaughn McClelland agrees; Michelle Manternach agrees; Bill Vosdingh agrees; and Steve Hart agrees. The 2022 CMLP Officers are Chair Steve Hart, Treasurer Vaughn McClelland and Secretary Michelle Manternach. Motion approved.

The December 13, 2021 meeting minutes were reviewed. With no additions or corrections, Trustee Vosdingh motioned to approve the minutes of the December 13, 2021 meeting, Treasurer McClelland seconds, 5 ayes and the motion carried. The minutes will also be posted on the City of Coggon's website.
