The campground project is complete however waiting on delivery of CT's. Once we receive the CT's they will be installed.

Quotes were received for a 16 ft gate to be installed at the Savage Park substation. Novak Fencing will install the gate.

Tested the Cummins engine on 9/13/2023 for one hour and it ran well.

The east side of 3rd Street, at the bottom of the hill, in the city right of way, is where the new substation will be installed. CMLP distribution lines are already buried going south up the hill, in the city right of way. Contractors have started clearing and prepping the area for a concrete pad. The 12,000 lb. transformer is on track to be delivered before December so the lot and concrete must be prepared prior to delivery.

Mary reached out to several different suppliers for additional quotes on poles with only one additional quote received. The board agreed that we need to have extras in our inventory and agreed to move forward with ordering.

The new payment portal will hopefully be able to go live on 11/6/2023.
