The Coggon Municipal Light Plant Board of Trustees met in regular session on Monday, August 17, 2020 via Zoom. This meeting was rescheduled from Monday, August 10th, 2020. On August 10, 2020 Coggon lost transmission at the substation. The generator automatically turned on to carry the town of Coggon until ITC repaired the transmission line and power was restored to the substation at 10:45 pm.

Employee Rundle will be working with Power Plant Compliance to ensure all Linn County Public Health Air Quality Division requirements are met and that the permit is revised.

Treasurer McClelland motioned to adjourn at 7:38 pm, Trustee Vosdingh seconds, 5 ayes and motion to adjourn carried.
