

Coggon Municipal Light Plant Board of Trustees Meeting Monday, January 13, 2020

The Coggon Municipal Light Plant Board of Trustees met in regular session on Monday, January 13th, 2020 at the Coggon Light Plant. The meeting was called to order at 7:04pm by Travis Heins. Those in attendance included, Trustees Travis Heins, Steve Hart, Vaughn McClelland and Michelle Manternach. Employee Mary Rundle was present and also newly elected Mayor Heather Beeh. Trustee Bill Vosdingh was absent.

An election of the 2020 officers of the Light Plant board was the first item on the agenda.

Trustee McClelland nominated Travis Heins for Chairperson. Travis announced that he would be resigning from the Light Plant board and this would be his last meeting. Trustee McClelland then nominated and motioned Steve Hart for Chairperson. With no other nominations, Michelle Manternach seconds, roll call vote: Michelle Manternach aye, Vaughn McClelland aye, Steve Hart aye, Travis Heins aye. Steve Hart accepts Chairperson.

Steve Hart nominated and motioned Vaughn McClelland for Treasurer. Michelle Manternach seconds, roll call vote: Michelle Manternach aye, Steve Hart aye, Travis Heins aye, Vaughn McClelland aye and accepts Treasurer.

Vaughn McClelland nominated and motions Michelle Manternach as Secretary. Steve Hart seconds, roll call vote: Vaughn McClelland aye, Travis Heins aye, Steve Hart aye, Michelle Manternach aye and accepts Secretary.

Travis Heins will be removed from the bank accounts and new signature cards will need to be signed by the new officers.

The November 18th 2019 meeting minutes were reviewed. With no additions or corrections, Chairperson Hart motioned to approve the minutes of the November 18th 2019 meeting, Secretary Manternach seconds, 4 ayes and the motion carried. The minutes will also be posted on the City of Coggon's website.

An employee review was next on the agenda. Treasurer McClelland motioned to change Employee Rundle's title from Bookkeeper to Office Manager/Interim Superintendent, Chairperson Hart seconds, 4 ayes, title change passed. Treasurer McClelland then motioned for a 3% increase, retroactive to the first of the year, Chairperson Hart seconds, 4 ayes, increase passed.

It was discussed to open bids for repairing the leaks in the roof of the main structure building.

Chairperson Hart motioned to approve the 2020 budget, Secretary Manternach seconds, 4 ayes, 2020 budget approved.

December and January Plant Update:

- Concrete project for the new fuel tank was completed and the new fuel tank is in place. It should be installed this week. The 16,000 gallon fuel tank will be removed sometime in the spring.
- Fransyl Equipment will order the necessary parts for the bucket truck and will make the necessary repairs.
- Cummins repaired a coolant leak in the engine.
- The annual inspection of the Cummins Engine will be this week.

Chairperson Hart motioned to adjourn at 8:07 pm, Treasurer McClelland seconds, 4 ayes and motion to adjourn carried.
